Melanie Conley, director of business services, gave a presentation on the workers comp consortium and the school health plan.

The board approved budget modifications (#282-286 for 21-22 and #20-39 for 22-23).

CTE had several vacancies to fill, enrollment was up about 100 students as of September (but there's often a drop in enrollment through mid-November).

Adult education open house September 23 at the Niagara Falls center (606 6th St.)

Approved bids for Co-op electric commodity to Energy Cooperative of America in Amherst for lighting and small and large commercial.

Approved several resignations, appointments, and a salary increase for a teacher aide.

The October meeting was held at the Newfane Early Childhood Center in Burt. BOCES had been in the building for several months, and we toured the classrooms and facility. They'd recently had several retirements and resignations, which affects classrooms.

Dr. Ron Barsyts, Director of Special Programs, and his staff gave a presentation on BOCES' Special Education Program.

The board approved a bid award for pool supplies, approved a lease agreement for Danielwicz Brothers, accepted a donation of a lizard tank for the popular Animal Science Program, and adopted a retention and disposition schedule for NY local government records.

There were several resignations and appointments—retaining staff is an ongoing issue.

The board approved a \$600 award for 100 staff for exemplary services. (This used to be an award for perfect attendance, but we don't want to encourage people to come to work when they're sick—especially considering COVID.)

We received a positive audit from Mengel Metzer Barr & Co. One suggestion was to continue to monitor several adult and continuing education programs, 5 of which ended the year with a deficit fund balance.
